

## AEP ENERGY "2023 Free Green Electricity for a Year Sweepstakes" Prize will be awarded in \$1,400 Prepaid Giftcards

Please read these rules before entering the AEP Energy "2023 Free Green Electricity for a Year Sweepstakes" (the "Sweepstakes"). By submitting an entry, you acknowledge that you have read and agree to be bound by these Official Rules and the decisions of the Sponsors (defined below) and that you satisfy all eligibility requirements.

## SWEEPSTAKES OFFICIAL RULES IS GOVERNED BY THE STATE OF OHIO LAW.

Eligibility: The Sweepstakes is open to all persons who, at the time of entry, are 18 years of age or older, legal residents of the United States residing in Ohio. Employees, officers, and directors (including immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of each of AEP Energy, Inc. (the "Sponsors") and its affiliates and agencies, and any and all other companies associated with the Sweepstakes are not eligible to participate in the Sweepstakes or to win the Prize (defined below). The Sweepstakes is subject to all applicable federal, state and local laws, rules and regulations. Void outside of Ohio and where prohibited or restricted by law, rule or regulation. How to Enter: The Sweepstakes entry period begins at 12:01 AM Eastern Time ("ET") on April 1, 2023 and ends at 11:59 PM ET on April 30, 2023 (the "Entry Period"). Limit of one (1) entry per eligible household, regardless of method of entry. In case of multiple entries received from any household, only the first entry received from such household will be considered. There are two ways to enter the Sweepstakes during the Entry Period entry and no other method of entry will be accepted.

Entrants must fill out all required fields on the entry form to participate in the Sweepstakes. After submitting the required information on the entry form, you will receive your one
- (1) and only entry into the drawing. Any completed forms that do not meet the eligibility requirements above will be omitted from the drawing at the end of the Entry Period.

Mail-in Method: You may also enter the Sweepstakes by hand-printing your full name, address, city, state and zip code, day and evening telephone numbers (including area codes), and email address on a 3" x 5" postcard and mailing it in a sealed envelope with proper postage affixed to: AEP Energy "2022 Free Green Electricity for a Year Sweepstakes" c/o AEP Energy, P.O. Mail-in entries become the property of the Sponsor and will not bereturned.

Information Collected and Privacy: Entrants may be given the option to receive commercial emails and/or other communications from Sponsors; however, eligibility to participate in the Sweepstakes is not dependent upon entrant's consent to receive such emails and/or other communications and consenting to receive such emails and/or other communications will not impact any entrant's chances of winning. By entering, an entrant agrees to be called, mailed or emailed by AEP Energy with information related to his/her entry.

Random Draw: A random draw for the Prize, by a Sponsor representative, or other person designated by Sponsor, will be held on or about the week of May 1st, from among all eligible entries received. The potential winner(s) selected in accordance with the above will be contacted by telephone and/or email at the telephone number and/or email address provided at the time of entry. If a potential winner(s) cannot be reached within two (2) days of the first notification attempt or declines the Prize, he/she will be disqualified, his/her Prize will be forfeited and, at Sponsor's discretion and time permitting, an alternate potential winner(s) may be selected at random from among remaining eligible entries. The amount of the Giftcards Prize is intended to represent an average residential household's annual cost of electricity in Columbus Southern Power and Ohio Power. The gift cards are subject to separate terms and conditions imposed by issuer. The grand prize winner is fully responsible for any and all applicable federal, state and local taxes (including income and withholding taxes) and will be required to provide the Sponsor with a mailing address, and complete and submit a W-9 form to claim the prize. All costs and expenses associated with Prize acceptance and use not specified herein as being provided are the sole responsibility of the winner. The winner is responsible for remitting payment to their respective utility company directly and will be responsible for any late fees, past due balances, etc.

Prize Conditions: No substitution or transfer of prizes or cash redemptions permitted, except at the sole and absolute discretion of the Sponsor.
